## Notification

The following ordinance, as approved by the Hon'ble Chancellor on 05-12-2008, is published herewith for information:

### ORDINANCE No. III (2)

#### Determination of the Seniority of Teachers

1. This Ordinance shall be called the Ordinance for the determination of the Seniority of Teachers.
2. The Ordinance shall come into force with immediate effect.
3. The seniority of teachers will be determined from the date of their appointment in the University provided that in case of a teacher who had been working as such at the inception of the University, his seniority shall be reckoned with effect from the date of his original appointment to the post concerned.
4. The seniority list of teachers of the University shall be prepared faculty-wise. There will be no common inter-faculty seniority list of the teachers. If, however, for any specific reason, the inter-faculty seniority of any teacher is required to be determined in the University as a whole, the Vice-Chancellor shall form a Committee, which will make recommendation in this regard along with full justification thereof within a time period specified by the Vice-Chancellor. The final decision on the recommendation shall thereafter be taken by the Vice-Chancellor.
5. It shall be the duty of the Principal of the College/Dean of the Faculty concerned to prepare and maintain faculty-wise seniority list of the teachers.
6. All disputes regarding seniority of the teachers of a faculty will be referred to a Senior Committee constituted by the Vice-Chancellor as and when so required. This Committee will

submit its recommendation to the Vice-Chancellor who will decide the dispute in terms of the provisions of this Ordinance. Any teacher aggrieved by the decision of Vice-Chancellor may prefer an appeal to the Chancellor of the University within thirty days from the date of communication of the Vice-Chancellor's decision to the teacher concerned. The Chancellor shall consider such representation and decide it. The decision of the Chancellor shall be final.
