ORDINANCE RELATING TO THE
MENACE OF RAGGING

Ordinance No. VII (6)

Ordinance Relating to the Menace of Ragging

Chapter-1 Preliminary

- 1) This Ordinance may be called the "Ordinance Relating to the Menace of Ragging".
- 2) It shall come into force with effect immediate.

Chapter-2 Definitions

- 3) In this Ordinance, unless the context otherwise requires:-
 - (i) "Chief Proctor" means Chief Proctor of the University.
 - (ii) "College" means a College of the University.
 - (iii) "Dean of Students Welfare" means Dean of Students Welfare of the University.
 - (iv) "Director" means the Director of an Institute.
 - (v) "Institute" means an institute of the University.
 - (vi) "Principal" means the Principal of a College.
 - (vii) "Pro Vice Chancellor" means Pro Vice Chancellor of the University.
 - (viii) "Ragging" means such acts as constitute ragging under the Regulations.
 - (ix) "Regulations" means "UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009"
 - (x) "University" means Swami Vivekanand Subharti University.

Chapter-3 Regulations

- 4) With a view to curb the menace of ragging, the University shall mutatis mutandis implement the Regulations, which form an annexure to this Ordinance.

Chapter-4 Statutory Bodies

- 5) The Vice Chancellor shall constitute an Anti-Ragging Committee in the beginning of every academic session, as envisaged in para 6.3 (a) of the Regulations, for each College/Institute of the University with the Principal/Director as the Chairman. The Anti-ragging Committee shall perform such duties and shall enjoy such powers as are laid down in the relevant provisions of the Regulations. The members of the Anti-Ragging Committee shall be nominated by the Vice Chancellor in accordance with the guidelines contained in the Regulations.

- 6) The Vice Chancellor shall constitute in the beginning of every academic session one or more Anti-Ragging Squad as envisaged in para 6.3 (c) of the Regulations with such membership as may be considered appropriate. The Anti-Ragging Squad shall perform such duties and shall have such powers as are laid down in the relevant provisions of the Regulations.
- 7) The Principal/Director of each College/Institute of the University shall, at the end of each academic year constitute, a Mentoring Cell as envisaged in para 6.3 (f) of the Regulations for performing duties as laid down in the relevant provisions of the Regulations. The Mentors shall be selected in accordance with the guidelines contained in the Regulations.
- 8) (1) There shall be a Monitoring Cell on Ragging headed by the Vice Chancellor with the following as members:
 - (i) Pro Vice Chancellor
 - (ii) Principal/Director of all the Colleges/Institutes of the University.
 - (iii) Dean of Students Welfare
 - (iv) Chief Proctor
- (2) The Chief Proctor shall also function as the Secretary of the Monitoring Cell.
- (3) The Monitoring Cell shall perform such duties and shall enjoy such powers as are laid down in the relevant provisions of the Regulations.
