Notification

The following ordinance, as approved by the Hon'ble Chancellor on 05-12-2008, is published herewith for information:

ORDINANCE No. II (1)

Selection of Wardens and Teachers as members of the Court

1. This Ordinance provides the manner in which wardens and teachers are to be selected for serving as members of the Court.
2. The Ordinance shall come into force with immediate effect.
3. The selection of Wardens and Teachers as members of the Court shall be done by Vice-Chancellor within the limits provided in Clause 6A (i) (e) and 6A (i) (f) respectively of the First Statutes.
4. The selection of wardens as members of the Court shall be done by the Vice-Chancellor from amongst the Wardens of the Boys & Girls Hostels;

Provided that one of the Wardens will be from the Boys Hostel and the other from the Girls Hostels;

Provided further that the same Warden shall not be selected for two consecutive terms.

5. Teachers shall be selected by the Vice-Chancellor from the faculties by rotation subject to the conditions that:
 - (i) not more than one teacher shall be selected from the same faculty;
 - (ii) the senior most teacher other than the Principal and the Dean of the faculty shall normally be selected ; and
 - (iii) the same teacher shall not be selected for two consecutive terms.

6. No Warden or Teacher, who is already a member of the Court in some other capacity, shall be eligible to be considered for selection as a member under this Ordinance.
7. Any teacher or warden aggrieved by the selection made by the Vice-Chancellor under this Ordinance can submit a representation to the Chancellor within two weeks of the aforesaid selection. A decision on such a representation shall be communicated by the Chancellor's Office to the aggrieved person within two weeks and the decision of the Chancellor so communicated shall be final.
